The preservation of Clapham and Wandsworth Commons for purposes of healthful recreation and enjoyment is a question of deep importance to the owners and occupiers of property in the neighbourhood and to the Public generally. The present Lord of the Manor claims the absolute ownership of Wandsworth Common, with a considerable portion of Clapham Common, and it is desirable for all parties that the question of right should be at once settled, instead of remaining in a state of uncertainty. Within the last quarter of a century Wandsworth Common has been diminished to about one half of its former area, and encroachments are continually taking place. The present condition of a large portion of the Common, the enclosures which have been made, the unsightly heaps of refuse from the ash-pits of the district, and the character of the buildings which have recently been erected, give some idea of the future uses to which the remaining 150 acres will be applied if Lord Spencer's claim be established.
